

## **Prohibited Items:**

1. Alcohol may not be brought into the Kentucky Exposition Center or any affiliated properties.
2. Food and Beverage:
  - a. Outside food or beverage may not be brought into the Kentucky Exposition Center or any affiliated properties unless so approved by the Kentucky State Fair Board, its officers, or its Lessee's.
3. Signs/Flags/Garments:
  - a. Unless otherwise approved: Patrons may not bring in signs, posters, or banners which exceed 8.5"x11". Signage may not be attached to a pole/stick, affixed to the ground using any mechanism, or any other mechanism of this nature.
  - b. Signage/garments shall not contain profane or derogatory content which includes calls to action, violence, or otherwise may contribute to danger to other patrons. Profanity/Derogatory content on display by vendor or patron shall be enforced in conformity with local, state, and federal laws regarding the 1<sup>st</sup> amendment.
4. Unapproved enclosures including camping tents, pop-up tent/changing station, tanning enclosure, etc. No temporary fixture with intended uses like these items may be prohibited in order protect the safety of other patrons or vendors as well as to ensure safe conditions in common areas, entrances, and exits of Kentucky Venue and its affiliate properties.
5. Unapproved drones/personal arial devices.
6. Explosives, flares, fireworks, and flammable liquid.
7. Noise Making Devices:
  - a. Includes air horns, whistles, and other devices unapproved by Kentucky Venue which has the intended usage of loud noises.
8. Unapproved Pamphlets/Handouts/ads which are outside designated free speech zones or outside approved locations.
9. Patrons without shoes and/or shirts.
10. Personal transportation within the buildings associated with Kentucky Venue
  - a. Includes: Skateboards, rollerblades, hoverboards, etc.
11. Mobility devices not ADA approved.
12. Pets other than service animals.
13. Masks other than medical, unless otherwise approved.

**this list is deemed dangerous to other patrons or disruptive to the event being hosted. KEC is expressly granted exclusive control over events hosted on the property owned and associated by the Kentucky State Fair Board and retain the right to institute appropriate regulations to promote the safety of its patrons, promote decency, ensure the execution of its events, and ensure the maintenance and upkeep of its facilities. ## **Inside Areas (Wings, Halls, and Arenas) Prohibited Items**

1. Outside alcohol not sold in relation to events put on or hosted by the Kentucky State Fair Board.
2. Outside food not sold in relation to events put on or hosted by the Kentucky State Fair Board.
3. Signs/Flags/Garments:
  - a. Unless otherwise approved: Patrons may not bring in signs, posters, or banners which exceed 8.5"x11". Signage may not be attached to a pole/stick or any other mechanism of this nature.
  - b. Signage/garments shall not contain profane or derogatory content which includes calls to action, violence, or otherwise may contribute to danger to other patrons. Profanity/Derogatory content on display by vendor or patron shall be enforced in conformity with local, state, and federal laws regarding the 1<sup>st</sup> amendment.
4. Unapproved enclosures including camping tents, pop-up tent/changing station, tanning enclosure, etc. No temporary fixture with intended uses like these items may be prohibited in order protect the safety of other patrons or vendors as well as to ensure safe conditions in common areas, entrances, and exits of Kentucky Venue and its affiliate properties.
5. Interchangeable/detachable Camera Lens related to or for the purpose of professional photography (Unless credentialed media or with approval from Kentucky State Fair Board).
6. Audio or visual recording devices for the purpose of professional or commercial media (Unless credentialed media or with approval from Kentucky State Fair Board).
7. Tripods/Monopod.
8. Personal transportation- including golf carts, hoverboards, motorized scooters/bikes, and other forms of personal transportation utilizing the facility through attendee deemed entrances.
9. Laser Pointers.
10. Laptop/Tablet computers (Unless credentialed media or with approval from Kentucky State Fair Board).
11. Large Bags (backpacks, large bags, suitcases, luggage): may not be larger than 14"x14".
12. Noise Making Devices:
  - a. Includes air horns, whistles, and other devices unapproved by Kentucky

Venue which has the intended usage of loud noises.

13. Balloons, Spray Paint, or Glitter.
14. Unapproved Pamphlets/Handouts/ads which are outside designated free speech zones or outside approved locations.
15. Patrons without shoes or shirts.
16. Throwable Sports Equipment and Projectiles.  
**\*\* Basketballs Are Allowed in the Building \*\***
17. Skateboards, rollerblades, hoverboards, bicycles, helmets, and chairs.
18. Umbrellas.
19. Pets other than service animals.
20. Coolers and Ice Chests (empty or containing outside food/drink).
21. Cans/Bottles/Flasks (glass or metal of any kind).
22. Masks other than medical, unless otherwise approved.
23. Illegal weapons, pepper spray, mace, etc.:
  - a. Open carry firearm owners and licensed concealed-carry firearm owners who are occupying the same spaces in which open carry statutes apply shall be exempt from this regulation as permitted by the Federal and Kentucky Constitution as well as federal and state statutes.
  - b. The Kentucky State Fair Board being vested with the authority of having exclusive control of all operations and events occurring upon the state fairgrounds and exhibition center and any other properties under the custody and control of the State Fair Board shall maintain the authority to implement regulations regarding firearm possession while on Kentucky State Fair Board property as necessary for the purposes of addressing: 1) to maintain decency and good order; 2) To protect the peace or safety of the general public; 3) To protect the public interest, convenience, or necessity; or 4) To govern the operation, maintenance, or use of property under its custody and control. This is pursuant to the authority granted by KRS 247.160 and KRS 247.145.
